**CONTRACT FOR CHILLED SEMEN DELIVERY**

Please read the entire contract carefully before signing.

I hereby confirm my reservation to the Clydesdale stallion:

Langbank Winsome Lad \_\_#M34085\_ for the year 2011

**TERMS AND CONDITIONS**

1. The breeding season referred to in the contract begins **February 10**, and ends **July 1** of the year 2011.
2. Wismer Clydes will ship semen from the above named stallion as many times as needed during the above stated breeding season, with a maximum of two shipments per heat cycle.
3. Wismer Clydes responsibility to this contract ends when the mare named below becomes pregnant or when the active breeding season ends.
4. Wismer Clydes does not offer a live foal guarantee but if the mare does not settle we will ship semen in 2012 for two heat cycles with no semen cost, but the usual collection and shipping fees will apply.
5. In the event that the mare aborts after Sept. 1, and is open we will ship semen in 2012 for \$400.00 for stallion fees plus all other collection and shipping fees as stated in this contract.
6. To qualify for free semen in 2012 we must know by September 1, 2011 that the mare did not settle.
7. The stud fee for the above named stallion is \$800.00 for the first mare and \$700.00 for any mares after that and is due before any shipments are made.
8. A \$300.00 deposit per horse is also due with the stud fee. All semen transportation and collection charges will be deducted from this deposit and the balance will be refunded upon return of the breeding certificate signed by a licensed veterinarian or technician.
9. A \$100.00 collection and handling fee per shipment will be charged and deducted from the deposit. The box does not have to be returned.
10. GST will apply to the above charges for all Canadian clients.
11. Wismer Clydes assumes responsibility only to deliver semen in viable condition at the time of delivery to the mare owners farm or other designated location. The semen must be administered by a licensed veterinarian or technician.
12. This contract shall be interpreted in accordance with the laws of the province of Ontario and its validity and administration shall be governed by such laws.
13. The parties agree that the terms and conditions stated herein set forth the entire agreement of the parties.
14. It is understood that the mare owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, injury, infection or otherwise and by any cause whatsoever, and therefore agrees to hold Wismer Clydes, Gerald, Richard & Ronald Wismer, any other person employed by, or associated with Wismer Clydes, harmless, for any and all damages associated therewith.
