**CONTRACT FOR ON FARM BREEDING**

Please read the entire contract carefully before signing.

I hereby confirm my reservation to the clydesdale stallion:

SBH Phoenix # M33276 for the year 2011.

**TERMS AND CONDITIONS**

1. The breeding season referred to in the contract begins **February 10**, and ends **July 1** of the year 2011.
2. Wismer Clydes responsibility to this contract ends when the mare named below becomes pregnant or when the active breeding season ends.
3. Wismer Clydes does not offer a live foal guarantee but in the event that your mare aborts after Sept. 1, and is open we will breed her in 2012 for \$400.00 for stallion fees plus board and other associated costs.
4. A deposit of \$100 per mare is required with this contract to ensure a breeding for the current year.
5. The stud fee for the above named stallion is \$800.00 for the first mare and \$700.00 for any mares after that, and the balance of the stud fee is due upon pickup of the mare.
6. Mare care will be \$10.00 per day for dry mares and \$12.00 for mares with foals.
7. If your mare is bred AI a one time \$75 collection fee will apply to each mare
8. GST will apply to the above charges for all Canadian clients.
9. Any mare that did not have a 2011 foal must be accompanied by a veterinary certificate showing that the mare is free of any reproductive tract infections.
10. This contract shall be interpreted in accordance with the laws of the province of Ontario and its validity and administration shall be governed by such laws.
11. The parties agree that the terms and conditions stated herein set forth the entire agreement of the parties.
12. It is understood that the mare owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, injury, infection or otherwise and by any cause whatsoever, and therefore agrees to hold Wismer Clydes, Gerald, Richard & Ronald Wismer, any other person employed by, or associated with Wismer Clydes, harmless, for any and all damages associated therewith.
